- FTZ's are "legally" deemed outside of US Customs territory
- Logistical competitive advantage
- Time and cost savings
- No duties ever paid on re-exported merchandise
- Duties paid only when nationalizing goods (cash flow)
- Minimal US regulatory oversight (goods are in transit)
- Commingle domestic & bonded merchandise without segregating
- Flexibility: re-package, re-label, assemble, and more

FTZ VS. Bonded Warehouses

	FTZ	Bonded Warehouse
Customs Entries	Admissions document is filed (as opposed to an entry summary)	Customs entry must be filed prior to goods arrival
Permissible Cargo	Foreign and domestic goods may be commingled	Foreign and domestic goods must be physically segregated
Importer's Bond	Not required for <i>admission</i> of goods (bond required for entries)	Importer's bond required for all warehouse entries
Storage Periods	Unlimited storage period	Time limits on storage
Permitted Activity	Goods may be inspected, repackaged, repaired, manufactured, assembled, and more	Limited manipulation activity allowed
Documentation Fees	Consolidated weekly entry allowed (Savings in time and processing fees: MPF)	Individual entries must be filed for each sales order
Regulatory Compliance	Reduced regulatory oversight for FTZ inventory (from agencies such as FDA, FCC, DOT, DOE, etc.)	Must file and adhere to all regulatory agencies

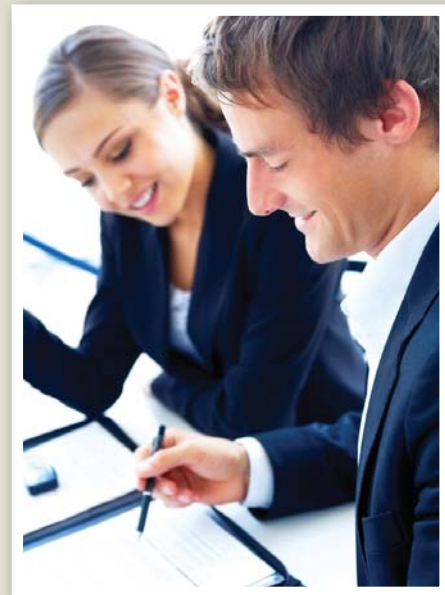
